

Miss Vermont Scholarship Organization Louis Vuitton Bag Raffle - OFFICIAL RULES

1. PROMOTION DESCRIPTION: The Miss Vermont Scholarship Organization Louis Vuitton Bag Raffle ("Raffle") begins on AUGUST 20TH 2020 at 8 AM and ends on SEPTEMBER 20TH 2020 at 8 AM *or when one hundred (100) raffle tickets are sold, whichever comes first (the "Promotion Period").

The sponsor of this Raffle is THE MISS VERMONT SCHOLARSHIP ORGANIZATION INC ("Sponsor"). By participating in the Raffle, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the Raffle.
